TISS is a centrally funded public university which operates from four campuses located in Mumbai and Tuljapur in Maharashtra, Guwahati and Hyderabad; and has expanded its education, training, research and outreach activities in several other states as well. TISS's off-campus at Hyderabad is the knowledge partner of the Sakhi One Stop Centers (OSC) Project with the Department of Women and Child Development, Government of Telangana to provide integrated support and assistance to women and children affected by gender-based violence, both in private and public spaces.

A Project Management Unit was set up in 2017 for implementation of the Sakhi OSCs in all the districts of Telangana and is located in the Directorate, Women Development and Child Welfare, Government of Telangana, Hyderabad.

Remuneration: Consolidated payment of Rs. 27,500/- per month.

Responsibilities:

- Liaison between TISS Mumbai and PMU for transfer of funds (both project funds and salaries to OSC and other projects)
- Assisting in Training and monitoring programmes, record keeping and UC submission.
- Prepare and send monthly expenses statements (Statement of Expenditure) to TISS and the TS WCD Department after coordinating with

Project Leader for necessary approvals.
