Application for the post of Academic Programme Manager (One Post) on Contract Basis for TISS- Hyderabad Off Campus

The Tata Institute of Social Sciences (www.tiss.edu), established in the year 1936 is a Deemed to be University, fully funded by the University Grants Commission, Govt of India. TISS is a Grade I University with NAAC score of 3.89/4 and is ranked 60 under NIRF University Rank Category for 2022.

With campuses at Mumbai (Main) and off-campus at Tuljapur, Guwahati and Hyderabad, TISS offers over 52 Post Graduate programmes, 18 Doctoral programmes, and 4 Under Graduate programmes in a range of socially relevant inter-disciplinary and applied social science disciplines, and over 30 B.Voc. programmes.

Freedom and autonomy shape the positive work ethos and culture of the Institute and facilitate strong linkages between teaching, research, field action and policy engagement. The Institute encourages and supports researchers to engage in foundational, applied, field and action-oriented research, and it also nurtures research collaborations nationally and internationally, with a commitment to creating a just society through education, generation of knowledge and field action initiatives.

The School of Public Policy and Governance (SPPG) has the mandate to create a cadre of public policy professionals who through their multi-disciplinary training respond to current policy challenges and incubate ideas to proactively meet future demands. The school provides interdisciplinary foundational training in Ethics and Policy, Economics (including econometrics), Law, Political Science, and Sociology. It encourages students to be reflexive in developing institutional designs that can transform public services. The School offers three post-graduate courses – MA in Public Policy and Governance, MA in Cities and Governance, and PGD in Cities and Governance

The school invites applications from interested candidates for **ONE post of Academic Programme Manager**. The post will be on contractual basis initially for a period of one year initially and extendable based on performance of the candidate and requirements of the school.

Monthly Remuneration: Rs. 60,000/- (Consolidated).

Job Description

The candidate will be in charge of the overall management and development of the School. This entails the organization of events (lectures, workshops, training programs), the management and development of academic and institutional partnerships (with research and academic partners, public and private organizations), the management of research projects, including fundraising/resource mobilisation (grant applications and private fundraising) and the operational management of field operations. The Academic Programme Manager will be responsible for the overall communications, news media and web presence of all programmes offered by the School.

Following will be the key job responsibilities

- a) Developing and sustaining academic and institutional partnerships with research and academic partners, public and private organizations
- b) Managing the academic matters of academic programmes offered by the School
- c) Create and curate relevant 'open source' resource for the students of the school
- d) Management of research projects, including fundraising/resource mobilisation (grant applications and private fundraising)
- e) Operational management of all field operations (internships and field works of the students)
- f) Developing a robust communication strategy with all relevant stakeholders
- g) Creating informative and engaging content (both written as well as digital) for dissemination of the school's activities to all stakeholders and media including social media.
- h) Creating and maintaining a basic data base related to students (placements & alumni)
- i) Any other matters as deemed by the Chairperson of the School

Essential Qualification

The candidate should have a Master's degree in any discipline with a minimum of 55% of aggregate marks with 2-3 years of relevant experience.

Desired Qualifications / Skill

- a) Ability to pursue a constructive approach and maintain professional relations with external agencies and organisations
- b) Good written and verbal communication skills in English and Hindi
- c) Command over computer skills and digital communication
- d) Openness and willingness to work with multidisciplinary team including students and researchers and promote team work

Application Fee

Application Fee: The application fee of Rs. 1000/- be paid online. The SC/ST/PWD candidates will be waived from the application fee if they attach the required certificate to the online application form. The women candidates are waived for payment of application fee. The application will be valid only on receipt of the application fee for those who are required to pay.

- c) The position is unreserved, but candidates belonging to reserved category are encouraged to apply.

- d) No queries or correspondence regarding issue of call letter for interview/selection of candidates for the post will be entertained at any stage and canvassing in any form is strictly prohibited and will lead to the candidate being debarred from consideration for the post.
- e) It shall be the responsibility of the candidate to assess his/her own eligibility for the post for which he/she is applying in accordance with the prescribed qualifications, experience etc., and submit his/her application duly filled-in along with the desired information and documents as per the advertisement. Suppression of factual information, supply of fake documents, providing false or misleading information or canvassing in any manner on the part of the candidates shall lead to disqualification. In case it is detected at any point of time in future, even after appointment, that the candidate was not eligible, his/her appointment shall be liable to be terminated forthwith as per this clause.
