**Required 'Assistant Professor' (ONE Post) on Contract Basis for the School of Media and Cultural Studies at TISS-Mumbai Campus.**

**Brief About School/Campus: School of Media and Cultural Studies , Mumbai Campus**

The **School of Media and Cultural Studies** for its **Centre for Critical Media Praxis in the Mumbai campus** invites application for **ONE** post of **Assistant Professor** to be filled on contract basis, initially for a period of one year and extendable based on performance of the candidate and requirements of the Institute.

**Remuneration:** - Consolidated salary of Rs. 81,624/- p.m. (Pay Band Rs. 15,600 – 39,100/- with AGP Rs. 6,000/- in 6<sup>th</sup> CPC as approved by funder).

**Eligibility Criteria:**

**Educational Qualification: Eligibility (A or B):**

**A.**

i) A Master's degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in Humanities and Social Sciences or Media and Cultural Studies or Film Making, Design, Fine Arts and allied fields from an Indian University, or an equivalent degree from an accredited foreign university.

ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph. D. degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SLET/SET:

Provided, the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bye-laws/Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of 'Assistant Professor' subject to the or equivalent positions in Universities/Colleges/Institutions fulfilment of the following conditions: -

- a) The Ph.D. degree of the candidate has been awarded in a regular mode;
- b) The Ph.D. thesis has been evaluated by at least two external examiners;
- c) An open Ph.D. viva voce of the candidate has been conducted;
- d) The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a referred journal;
- e) The candidate has presented at least two papers based on his/her Ph.D. work in conferences/seminars sponsored/funded/supported by the UGC/ICSSR/CSIR or any similar agency.

The fulfilment of these conditions is to be certified by the Registrar or the Dean (Academic Affairs) of the University concerned.

**Note:** NET/SLET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SLET/SET is not conducted by the UGC, CSIR or similar test accredited by the UGC, like SLET/SET.

**OR**

**B.** The Ph.D. degree has been obtained from a foreign university/institution with a ranking amongstop 500 in the World University Ranking (at any time) by any one of the following:

- i. Quacquarelli Symonds (QS)
- ii. the Times Higher Education (THE) or
- iii. the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University(Shanghai).

**Desirable Qualifications:**

- The incumbent will be required to teach courses in documentary theory and practice. Hence, experience in documentary and video/film production is a necessary qualification. Links to the documentary and video/film production work of the candidate can be provided in support of the application.
- The incumbent will also be required to teach courses in Visual Design.
- Two years of experience in media production, including online media.
- Research, published work, and media production, including online media, in the fields of study of the School of Media and Cultural Studies.

**Application Fee:** The application fee of Rs. 1000/- be paid online. The application fee for SC/ST/PWD candidates will be Rs. 250/- if they attach the required certificate to the online application form. The women applicants are waived from payment of application fees. The application will be valid only on receipt of the application fee, if applicable. Fees once paid shall not be refunded under any circumstances.

**The candidates those who have already applied to the post w.r.t advertisement No. ADVT/TISS/ACAD/MARCH/2023 dated 04 March 2023 need not apply again. Their applications will be considered as per the rules.**

### **Other Conditions:**

- The Institute reserves the right to relax the qualifications of the candidate based on the work experience and to relax age in the case of persons already holding comparable positions in a University/Research Institution of repute.
- The Institute reserves the right to invite persons for interviews who may not have applied as per the above procedure and not fill up the vacancy advertised.
- Since applications received may be short-listed, merely possessing the prescribed qualifications and the requisite experience would not entitle a person to be called for the interview.
- The post is unreserved, but candidates belonging to the reserved category are strongly encouraged to apply.
