NOTICE INVITING QUOTATION FOR COW MILK 2018-19

Sealed quotations are invited for Cow Milk as per terms and conditions for Dining Hall at Main Campus, new campus and guest house at TISS, Deonar, Mumbai-400 088. The intending bidders shall submit their quotes in a **sealed cover with name of the firm & title of quotation (ie. Quotation for Cow Milk) super scribed on the envelope** addressing to **“The Registrar’s Office, Tata Institute Of Social Sciences, V. N. Purav Marg, Opp Deonar Bus Depot, Deonar, Mumbai- 400088”**.

We shall expect the following terms and conditions:

1. It is expected to provide fresh, pure Cow milk at all the times. We do not require fully or partially toned &/or combination of milk. Adulteration of milk in any form is never acceptable and this is liable to termination of contract and black-listing of the vendor.
2. Rate should be mentioned for per liter and per 6 liters as specified in the annexure for each. Also mention Nutritive value of Carbohydrates, Protein, fats, Energy per 100ml and % SNF of Cow Milk in the annexure.
3. Quoted rates shall be inclusive of all taxes (GST or any other tax) and transportation charges. The Institute will not entertain any claim whatsoever in this regard. Changes in MRP leads to change in the offered price of milk. The change of price of Milk should be intimated timely.
4. The Milk packages should be intact and leak free during transportation.
5. The total monthly requirement of Milk for all 3 Dining halls is approximately 350-400 liters. The quantity of milk depends upon the menu and seminar orders. Kindly note that the requirement reduces during Summer vacation and Diwali vacation.
6. The milk should be delivered to respective Dining Halls of TISS Mumbai Campus at 4.00am daily.

7. Milk should always be supplied along with an appropriate Challan. The bills should be submitted fortnightly.
9. The Institute reserves right to reject the inferior quality of supplies and will not pay for the same. The Institute's decision in this regard will be final.
10. Vendor should obtain necessary gate pass from the Security Officer at the Main campus gate.
11. In case of new supplier, a trial period of 15 days is mandatory for checking upon the feedback of the students and status with bulk order of Milk.
12. At the time of submission of quotation, we appreciate sample of Milk which will be tested for drinking, tea & curd preparation. It is mandatory to submit latest copies of appropriate food licences for the Product under consideration.
15. Bills for 15 days should be submitted for which the payment will be made through NEFT.

Kindly submit the quotations along with Milk sample (1 liter) on or before 28th March'18.
